1. General information

7. Data storage

8. Transfer of data to third parties

Personal data may be transferred to external systems, such as CRM Bitrix24.eu, which operates as a cloud service. We use this system to manage data in a manner consistent with GDPR requirements, ensuring appropriate security measures.

9. International data transfers

We do not transfer personal data outside the European Economic Area.

10. Data security

In order to protect personal data, we use:

- Limiting access to data,
- Regular audits and security checks.

11. User rights

Each user has the right to:

- Access to your personal data,
- Rectification of data,
- Deletion of data ("right to be forgotten"),
- Processing restrictions,

- Object to processing,
- Withdrawal of consent to data processing.
